Unidentified male called HQ 4 times from a withheld number to ask about Laura Ordaz and check her welfare. (Laura was transporrted from Middlesex County Jail to Sussex County Jail on warrants on Monday, 12/22.) Caller said he is not a relative, just a facebook friend, and he and others are concerned about her. He was advised there is no need to be concerned, the department is aware of her circumstances, and no information can be given to him at this time. He was unreasonable, stated several times all police are corrupt and the court is corrupt. He would not wait to speak to a supervisor. During the 4th call he said he and others will come to Laura's house in Vernon this weekend. Cpl Mutz advised.

2251- Woman named Amy called HQ from a withheld number asking about Laura, same deal. Ptl Russo at HQ handling the phone call.

2305- Ptl Russo responding to residence at 3 Vanderhoof Court to see if anyone is there. Amy refused to give a callback number and will call back later so Ptl Russo can tell her the results of the welfare check.

2320- 50 spoke to Laura's sister who is staying at the house and obtained information that might put her facebook friends in touch with the sister. No report.


